Dear Lot Owner and Neighbor,

The annual Sherwood Lake Association, Inc. assessment for all lot owners is due on March 1<sup>st</sup> of each year. Lots 1-81 are lake lots and lots 82-313 are off-lake lots.

The Board Policy for dues collection is as follows:

- *In accordance with Part IV Lake Covenants, of the Restrictions and Protective Covenants of Lake Sherwood Acres, all annual assessments are due on March 1 of each year.*
- *Any assessment not paid in full by April 1 shall incur a late fee of \$100.00 and monthly charges at the legal rate of interest as provided by Louisiana law from the March 1 due date until full payment is received. (Please note – Late Fee assessed on April 1)*
- *If full payment of the assessment and interest charges, if any, is not received by April 30, a lien will be filed against the property owners. The costs of collection, including but not limited to reasonable attorneys' fees will be added to the amount due.*
- *If no payment is received by May 30, the lien will be converted to a legal action and any additional costs for this litigation will be added to the total amount due.*

Please fill out and return the form below, **including the names of all lot owners**, along with your check. Please indicate your lot number on the check (shown on the mailing label and your Welcome Packet). Incomplete information will cause a delay in posting your check. **If you have already sent a check, thank you, but I have returned it. Please complete the form and return it with your check.** If there has been a change in lot ownership, please notify me (225-291-5295) as soon as possible so the new owner may be properly contacted and recorded.

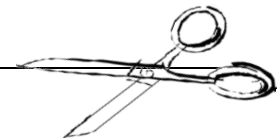
Since we are communicating with the residents primarily by email now, **it is imperative that you fill in your email address, even if you have provided it last year.**
